SUPPORT SA TALENT FOUNDATION RULES

- The Support SA Talent FOUNDATION is currently available to assist Road Cyclists who are CSA-registered and hold a Full Racing License - Road Cycling Athletes only ("QUALIFYING ATHLETES");
- Qualifying Athletes must be in the Junior, Under 23/ Elite category only (Women or Men's);
- Athletes must be residing in South Africa (i.e. not commuting to races from abroad), must have a valid Full Racing CSA-license and must be registered in a local South African Team or Club and cannot be contracted to a UCI-registered World Tour, Womens Tour or Pro Continental Team;
- The Application Form should be completed by the Qualifying Athlete, priority will be given to those who have provided the required information.
- Selection for funding will be made on the information contained in the Application Form and the FOUNDATION rules as well as those defined in the ATHLETE REWARDS PROGRAMME.

- Priority will be given to Qualifying Athlete, who have been selected to represent South Africa in a UCI World Championships, Continental Championships and/or African Games or contracted to a Continental Team and participating in a UCI Continental Circuit events.
- Applications may also be considered for other international tours and events, as decided by the FOUNDATION from time to time.
- Application Forms should be completed and returned to info@supportSATalent.co.za.
- Once approved for funding, Athletes are expected to adhere to the following:
- Provide a post event report by email within 3 days of the end of the event, containing details of the event and results obtained;
- Inform FOUNDATION immediately of any positions or competitions won, so that it can consider issuing publicity related to this;
